What are cookies?

A cookie is a small text file that is recorded by an Internet site on a PC or a mobile device of a user when they visit the site. Cookies are widely used to perform or to improve the effectiveness of work of the site, as well as to obtain information by the owners of the site. Cookies do not represent a threat to your PC, because they are text but not the programs which might run.

What are the types of cookies?

Required cookies – cookies, required for proper operation of the Site. They allow to use certain functions of the Site, for example, provide security for logging into the account on the Site.

Analytical / working cookies — with the help of these files data on the number of users of the Site is collected, their choice of information during the search, and other data, necessary to improve the functionality of the Site. Functional cookies — cookies, which are used to recognize a user when he visit the Site again. They help to personalize the content of the Site, save selected settings, etc.

Advertising cookies / Third-parties cookies – using these files information about the user's behavior on the Site is used to show him targeted advertising or other information interested to him.

How does the Company use cookies?

- 1) The Company uses cookies to collect information about the user's IP address and user's behavior, for example, about the visited sites and the time, spent on each site. It allows the Site to remember the system and user settings.
- 2) Other cookies allow the Company to track user flows and user's actions on the Site: the Company uses this data to analyze user behavior and improve the usability of the site. These cookies are installed and used with the help of Google Analytics tool.

The Google Analytics cookies and Doubleclick cookies are used for a variety of purposes related to their services and advertising. Cookies collects different information about the user and are used to identify unique users with a unique identification number (ID) assigned to them.

Cookies are installed on the user's device only after visiting the Company's website. It should be noted, that if the user disconnects cookies in his browser, some of the site's functions may be partially or completely unavailable for him.

The legal basis for the use of cookies by the Company is its legitimate interest in ensuring the technical functioning of the site. In cases, where cookies are used to recording user settings and collecting statistics, the legal basis for using cookies is the user's consent.

How long does the Company store data?

The Company uses the collected data for analysis for three years.

User's rights and order of use them

The user can exercise his rights, including the rights, associated with the processing of personal data using cookies. For that purpose, user should contact the Company by email sta@sta-logistic.com or by other contact information of the Company. During submitting an application, it is necessary to present an identity document or to be identified in accordance with the procedure, established by legal acts, by electronic means of communication, which allows to properly identify a person and confirm his identity.

User's rights:

- To get acquainted with your personal data, subject to processing;
- To require the rectification of his personal data;
- To require the erasure of his personal data;
- To withdraws his consent to the processing of personal data (if applicable);
- To require the transfer of his personal data (if applicable).

In some cases the user has the right to require the imposition of restrictions on the processing of his personal data or not to consent to the processing of his personal data.

In the event of the removal of personal data at the request of the user, the Company keeps copies of only information, which is necessary to protect the legitimate interests of third parties compliance with government requirements, dispute resolution and interference recognition.

How to manage with cookies?

User can delete all cookies on his device. In most browsers it is possible to set a ban on the installation of cookies.

Anonymity function
